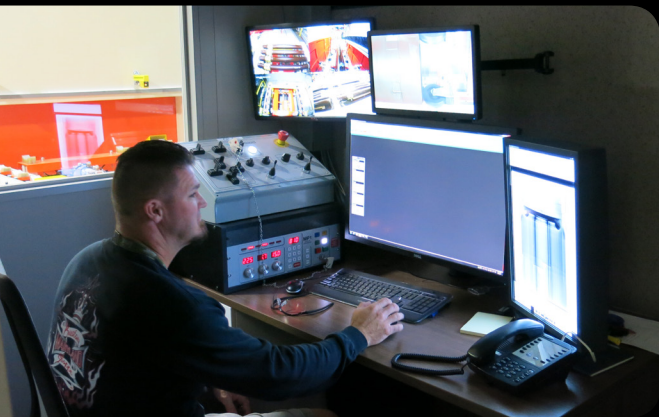


## ADDITIONAL CAPABILITIES

- 200-container per 24-hour contingency operations requirements shipping capacity
- Primary Containerization Dock
  - Eight 89-foot rail cars
  - 100-container stuffing operation capacity
- Secondary Containerization Dock
  - 100-container stuffing operation capacity
- 23 Remaining Docks
  - 528-container stuffing operation capacity
- Close proximity to major airheads, ports and transportation routes

## DEMILITARIZATION

### OPEN BURN/OPEN DETONATION:

- Fully permitted under RCRA Part B
- Maintain working relationship with PA Department of Environmental Protection
- 500 lbs. N.E.W. per demo shot; 10-28 shots/day
- 1,000 lbs. N.E.W. per burn tray/24 trays



### AMMONIUM PERCHLORATE ROCKET MOTOR DISPOSAL FACILITY (ARMDF):

- Disposal of Ammonium Perchlorate-propellant tactical rocket motors
- Static fire of rocket motors in confined burn chamber
- Environmentally friendly
- All by-products non-hazardous
